1.1 SCOPE

This project consists of the complete retrofitting of all field pole mounted lighting for all twenty-three (23) light poles in the fields at Bel Aire Park and Lakes by the Bay Park, Cutler Bay, as shown on project plans.

The scope of the project consists of the installation of new artificial turf surfaces at the existing playground areas of Bel Aire, Lakes by the Bay and Saga Bay park. The contractor shall perform all work indicated in scope below:

- 1. Removal of existing mulch and rubberized surfaces and wood borders.
- 2. Construction of new concrete border (except Lakes by the Bay park, which is to remain)
- 3. Installation of artificial turf surface and safety pole pads per the plans and specifications.

GENERAL SCOPE OF WORK-

THE SCOPE OF THIS PROJECT CONSISTS OF THE COMPLETE RETROFITTING OF ALL POLE MOUNTED FIELD LIGHTING FOR ALL TWENTY-SEVEN LIGHT POLES IN THE PLAYING FIELDS. ELECTRICAL CONTRACTOR SHALL PERFORM ALL WORK INDICATED IN SCOPE BELOW:

- 1. UNINSTALL ALL EXISTING FIELD POLE LUMINAIRES AND SUPPORTING STRUCTURES ATTACHED TO THE EXISTING POLES.
- 2. INSTALL NEW LED LIGHTING FIXTURES AND SUPPORTING STRUCTURES ON EACH POLE AS SHOWN ON DRAWINGS.
- 3. ALL RACEWAYS FEEDING FIELD POLE LIGHTING SHALL BE TESTED FOR GROUND FAULT AND INSULATION. FOR FAULTY RACEWAYS, UNINSTALL ALL BRANCH CONDUCTORS FEEDING LIGHT POLES FROM THE EXISTING ELECTRICAL DISTRIBUTION PANEL AND INSTALL NEW CONDUCTORS AS INDICATED IN ELECTRICAL PANEL SCHEDULE AND PARTIAL ELECTRICAL RISER.
- 4. ELECTRICAL WORKS FOR THIS PROJECT SHALL NOT INTERFERE WITH EXISTING BUILDING'S ELECTRICAL INSTALLATIONS.
