  - o SW 89 Avenue between SW 200 Street and SW 198 Street
  - SW 88 Place between SW 200 Street and SW 198 Street
  - SW 88 Court between SW 200 Street and SW 198 Street
  - SW 87 Place between SW 200 Street and SW 198 Street
  - o SW 87 Court between SW 200 Street and SW 198 Street
  - o SW 200 Terrace from SW 200 Street to SW 87 Avenue
- Sidewalk repairs and site restoration
- Milling and resurfacing of existing roadway located within the project limits
- Drainage Improvements

PROJECT BACKGROUND: This project is part of the Town's Stormwater Master Plan and the Miami Dade County Local Mitigation Strategy that will improve the stormwater management system and treat runoff pollutants within this sub-basin as well as roadway resurfacing. The goal of this project is to improve the existing drainage system by adding supplementary catch basins, replacing some existing catch basins, installing additional supplementary exfiltration trenches and pipes, milling and resurfacing of roadways and sidewalk repairs.
